Distillery Registration Form

Booth Space:

Each 10x10 space includes a table, 2 chairs, electric, water, and ice if needed. The distillery is responsible for its own tent and weights. We ask that you please have someone present at your booth at all times throughout the festival

Set Up:

The festival will be **Saturday, October 26 from 2-5pm**. You can load in either Friday, October 25th (8a-5p) or the morning of the event from 9am-1pm.

Tickets:

All distilleries will receive up to 4 wristbands and glasses for the festival for their workers. Distilleries attend the festival at no cost.

Product:

Please provide us with a list of product that you intend to serve at the festival. We suggest bringing enough product to serve around 400-500 guests. We will provide updates on ticket sales as the event approaches. The distillery is responsible for supplying any promotional material and/or signage to help promote the distillery/product.

Bottle Sales:

Bottle sales will be allowed from 5:01pm-5:45pm at the completion of the event. In order to sell bottles you must have an available tasting room permit and complete the required permitting information with the State of Colorado.

Deposit & Compensation:

Due to our experience with no shows at previous events, there is \$50 deposit required in order to secure your spot. This deposit will be returned to you via check at the event. Distillers who register by **5pm on Friday August 30** will ALSO be paid a \$200 travel stipend at the event (So you will be issued a \$250 check at the event).
